PRIVACY POLICY

Information pursuant to art. 13 of the Privacy Code

Pursuant to article 13 of the code of Legislative Decree 196/2003, we provide you with the following information.

We at www.cirmtmas.it believe that the privacy of our visitors is extremely important. This document describes in detail the types of personal information collected and recorded by our site and how it is used.

Recording Files (Log Files)

Like many other websites, ours uses log files. These files simply log site visitors – usually a standard procedure of hosting companies and hosting analytics services.

The information in log files includes Internet Protocol (IP) addresses, browser type, Internet Service Provider (ISP), information such as the date and time stamp, referring pages, exit and entry pages, or the number of clicks.

This information is used to analyze trends, administer the site, track users' movement on the site, and gather demographic information. IP addresses and other information are not linked to personally identifiable information, so all data is collected absolutely anonymously.

This website uses cookies

Cookies are small text files that are automatically placed on the navigator's PC within the browser. They contain basic information on Internet browsing and thanks to the browser they are recognized every time the user visits the site.

Cookie Policy

This site uses cookies, including third-party cookies, to improve the browsing experience, allow users to use any online services and monitor navigation on the site.

How to disable Cookies

It is possible to disable cookies directly from the browser used by accessing the settings (preferences or options): this choice could limit some navigation features of the site.

Management of Cookies

The cookies used on this site may fall into the categories described below.

➤ *Activities strictly necessary for operation*

These cookies are technical in nature and allow the site to function correctly. For example, they keep the user connected while browsing, preventing the site from requiring you to log in multiple times to access subsequent pages.

➤ *Preference saving activity*

These cookies allow us to remember the preferences selected by the user while browsing, for example, they allow you to set the language.

➤ *Statistics and audience measurement activities (e.g. Google Analytics)*

These cookies help us to understand, through data collected in anonymous and aggregate form, how users interact with websites by providing information relating to the sections visited, the time spent on the site, any malfunctions. This helps improve the performance of websites.

➤ *Social media cookies (e.g. Facebook)*

These third-party cookies are used to integrate some popular features of the main social media and provide them within the site. In particular, they allow registration and authentication on the site via Facebook and Google Connect, sharing and commenting on site pages on social networks, enabling the "like" functionality on Facebook and the "+1" on G+.

Purpose of the processing

The data may be collected for one or more of the following purposes:

- provide access to reserved areas of the Portal and Portals/sites connected to this and to send communications, including commercial ones, news, updates on the initiatives of this site and of the companies controlled by it and/or connected and/or Sponsors.
- possible transfer of the aforementioned data to third parties, always aimed at creating email marketing campaigns and sending commercial communications.
- carry out the obligations established by laws or regulations
- contact management

Treatment methods

The data will be processed in the following ways:

- data collection with single- opt mode , in a specific database;
- recording and processing on paper and/or magnetic support;
- organization of archives in a predominantly automated form, pursuant to the Technical Regulations regarding minimum security measures, Annex B of the Privacy Code.

Mandatory nature

All requested data is mandatory.

Rights of the interested party

Pursuant to art. 7 (Right of access to personal data and other rights) of the Privacy Code, we inform you that your rights regarding data processing are:

- know, through free access, the existence of data processing that may concern you;
- be informed about the nature and purposes of the processing

- obtain from the owner, without delay:
 - confirmation of the existence or otherwise of personal data concerning you, even if not yet registered, and communication in an intelligible form of the same data and their origin, as well as the logic and purposes on which the processing is based; the request can be renewed, unless there are justified reasons, with an interval of no less than ninety days;
 - the cancellation, transformation into anonymous form or blocking of data processed in violation of the law, including those whose retention is not necessary in relation to the purposes for which the data were collected or subsequently processed;
 - updating, rectification or, if interested, integration of existing data;
 - object in whole or in part for legitimate reasons to the processing of personal data concerning you even if pertinent to the purpose of the collection;

1. Data controller

The Data Controller is the CIRM International Radio Medical Center Foundation with registered office in Rome (RM), Via dell'Architettura 41, CF80208170581, in the person of the President Amenta Francesco

(hereinafter, "Owner").

2. Object of the treatment

The Data Controller processes the images coming from the surveillance cameras placed over the company structure for the purposes reported in point 3 of this information.

3. Purposes and legal bases of the processing

The Data Controller pursuant to articles. 13-14 GDPR informs you that it uses a video surveillance system to control access and external company spaces, around the perimeter of the structure, in order to preserve and protect its company assets and prevent illicit acts.

The images taken by surveillance cameras are processed exclusively for security purposes. The legitimate interest of the Data Controller to protect its assets and prevent illicit acts [pursuant to art. 6 co. 1 letter f) GDPR] constitutes the legal basis of the processing.

The recorded images are also used to fulfill specific requests from the judiciary or law enforcement agencies

and in this case the legal basis of the processing is constituted by the legal obligation [art. 6 co. 1 letter c) GDPR].

4. Treatment methods

The Data Controller processes your personal data in compliance with EU Regulation 2016/679 with automated and logical methods strictly related to the purposes, recording the images on special video recording equipment. The treatments are protected by adequate security measures. The Owner does not disseminate the recorded images or send them abroad.

The presence of the video surveillance system is made public through the installation of signs identifying the monitored areas.

5. Subjects to whom the data is communicated or who becomes aware of it

To pursue the purposes reported in point 3 of this information, your personal data may be communicated to third parties such as, for example, video surveillance equipment maintenance companies, security institutes, companies that manage IT networks and systems.

The data is not disclosed, sold or exchanged with third parties, except for use in the event of crimes perpetrated against the Company

and in this case the images are made available to the competent authority (judicial or police authority).

6. Data retention

The data is recorded and stored for a maximum duration of 72 hours with subsequent automatic deletion

(overwriting/over-recording), unless specifically requested by the Judiciary or the police.

7. Rights of the interested party

In your capacity as an interested party, you have the rights provided for in articles 15-22 GDPR which can be exercised by sending to the following references:
